IN EXERCISE of the powers conferred on the Minister of Trade and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulations are hereby made —

Citation

1. These Regulations may be cited as the Control of Goods, Prices and Other Charges (Petroleum Prices) (Amendment) (No. 1) Regulations, 2015, and shall come into force on 14th February, 2015.

2. The Control of Goods, Prices and Other Charges (Petroleum Prices) Regulations are amended in Regulation 3 (a) (i) and (ii) by substituting for the words “a levy of 40 thebe per litre in respect of the Road Fund”, the words “a levy of 60 thebe per litre in respect of the Road Fund”.
