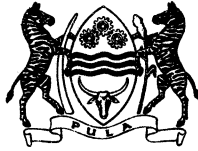

| <p>4. The Minister of Finance and Development Planning may issue a warrant for the payment from the Development Fund for the year ending 31st March, 2017 of the sum of P14, 821, 209, 754 (Fourteen Billion, Eight Hundred and Twenty One Million, Two Hundred and Nine Thousand, Seven Hundred and Fifty-Four Pula).</p> | Expenditure from Development Fund |
