| (a) in subbye-law (3) by substituting for the word “P10” appearing therein, the word “P20”; and | |
| (b) in subbye-law (5) by substituting for the words “P50 and to imprisonment for three months” the words “P200 or to imprisonment for a term not exceeding three months, or to both”. | |
| 3. Bye-law 4 is amended in subbye-law (5) by substituting for the words “P50 and to imprisonment for three months”, the words the, “P200 or to imprisonment for a term not exceeding three months, or to both”. | Amendment of Bye-law 4 of the Bye-laws |
| 4. Bye-law 7 is amended by substituting for the words “50 thebe” wherever they appear, the word “P50”. | Amendment of Bye-law 7 of the Bye-laws |
| 5. Bye-law 9 is amended in subbye-law (1) by substituting for paragraph (a) appearing therein, the following new paragraph —
“(a) agree, undertake or purport to cede or transfer his licence or certificate of registration, but may hire the services of a hawker or vendor representative to hawk or vend on his behalf during his absence, upon approval, in writing, by the licensing authority.”. | Amendment of Bye-law 9 of the Bye-laws |
| 6. The Bye-laws are amended by substituting for Bye-law 12 appearing therein, the following new Bye-law — | Amendment of Bye-law 12 of the Bye-laws |

- “Offences and penalties* 12. (1) Any person who contravenes any provision of these Bye-laws, or who fails to comply with any provision with which it is his duty to comply shall be guilty of an offence and liable, where no other penalty is herein provided, to a fine of P100 or to imprisonment for a term not exceeding three months, or to both.
- (2) Any person who contravenes any provision of these Bye-laws may, in addition to any penalty to which he may be otherwise liable, have his hawker’s license or his certificate of registration, as the case may be, revoked by the licensing authority, with effect from such date as the licensing authority considers reasonable, in order to enable him to dispose of any existing stock.”.
