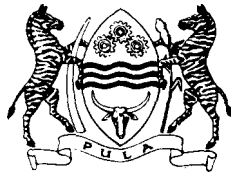

An Act to authorize the raising by the Government of loans from the African Development Bank, The African Development Fund and the International Fund for Agricultural Development, for the purpose of financing the Arable Land Development Programme.

| <ol style="list-style-type: none">1. This Act may be cited as the Arable Lands Development Programme Loan (Authorization) Act, 1981.2. The Minister may, subject to such terms and conditions as may be agreed between him and any of the financial institutions mentioned herein, raise by loans from –<ol style="list-style-type: none">(a) the African Development Bank sums not exceeding in the aggregate the equivalent of 7 200 000 units of account (seven million, two hundred thousand units of account;(b) the African Development Fund sums not exceeding in the aggregate 6 700 000 Fund units of account (six million seven hundred thousand units of account; and | <p>Short title</p> <p>Authorization to raise loans</p> |

(c) the International Fund for Agricultural Development sums not exceeding in the aggregate SDR 6 750 000 (six million seven hundred and fifty thousand special drawing rights).

3. The proceeds of the loans authorized to be raised by this Act (hereinafter referred to as "the loans") shall be paid into the Consolidated Fund.

4. All sums required to repay the loans and to pay the interest and other charges thereon shall be charged upon and paid out of the Consolidated Fund.

5. The Minister is hereby empowered to sign on behalf of the Government or to authorize any public officer so to sign any agreements embodying the terms and conditions of the loans and to do all such things as may be necessary or expedient to effect or facilitate the loans and such agreements.

6. As soon as practicable after the raising of the loans the Minister shall lay before the National Assembly a paper containing a report on the loans which shall include the terms and conditions of the loans and any other information relating thereto which the Minister considers appropriate to include.
