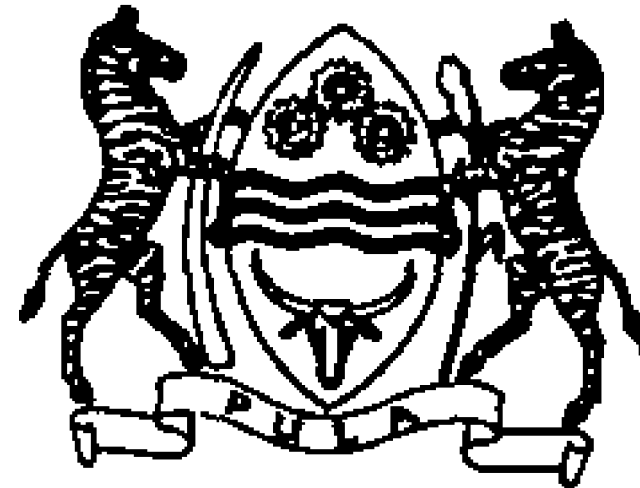

The sum authorised by section 2 is appropriated to and shall be applied for purposes of the Heads of Expenditure set out in the first and second columns of the Schedule, in the amounts set out in the corresponding entries in the third column of the said Schedule. | Appropriation of sum authorised by section 2 |

The Minister of Finance and Development Planning may issue a warrant for the payment from the Development Fund for the year ending 31st March, 1988, of the sum of P447 873 000 (four hundred and forty seven million eight hundred and seventy three thousand pula). | Expenditure from Development Fund |
