IN EXERCISE of the powers conferred on the Minister of Presidential Affairs and Public Administration by section 20 (1) of the Control of Security Guard Services Act, the following regulations are hereby made —

Citation

1. These Regulations may be cited as the Control of Security Guard Services Regulations, 1987.

Application for a licence

- 2. (1) An application for a security guard licence shall be made to the Controller in Form 1 set out in the Schedule hereto, and shall contain all the information specified in section 5 of the Act.
- (2) An applicant or his representative shall, if requested by the Controller to do so, furnish in writing any further information that the Controller may require, or, where the Controller seeks to interview him or his representative, attend such interview.

Issue of a licence

- 3. (1) The Controller shall, after consideration of an application made under regulation 2, issue the applicant with a licence upon payment by the applicant of the fee prescribed in regulation 15.
- (2) The Controller shall, in writing inform the applicant of his decision regarding his application for a licence in the form set out in Form 5A of the Schedule hereto.

Period of validity of licence 4. A licence issued under these Regulations shall, unless previously cancelled or surrendered, be valid for 12 months from the date on which it was issued.

Renewal of licence

5. (1) A licence may, upon its expiry, be renewed by application to the Controller in Form 1 set out in the Schedule hereto, and every such

application shall be accompanied by the fee prescribed in regulation 15.

- (2) Every application for the renewal of a licence shall be made not later than two months before the licence expires.
- (3) The Controller shall, in writing, inform the applicant of his decision regarding his application for renewal or a licence in the form set out in Form 5A of the Schedule hereto.
- 6. No person who has been issued with a licence shall transfer such Restriction licence to any other person without first obtaining the written consent of the Controller.

on transfer of licence

7. Every licensee shall display his licence in a conspicous place within his business premises.

Display of licence

8. (1) Every licensee shall maintain a record of names of his employees, dates of their employment, dates of termination of their services and the reasons for such termination.

Maintenance of records and annual returns

- (2) Every licensee shall submit to the Controller not later than 60 days after the end of the calender year in which his licence was issued or renewed, an annual return in respect of his employees giving the number and names of his employees. and the names of employees dismissed from his employ.
- 9. Every licensee shall make available for inspection by the Controller or a police officer upon demand his licence or any record in respect of his employees.

Inspection of records

10. (1) Every licensee shall ensure that whenever a security guard is on duty such security guard displays on his person an identity card which shall be in the form set out in Form 6 of the Schedule hereto.

Display of identity cards

- (2) It shall be an offence for a security guard not to display his identity card on his person whenever he is on duty.
- (3) Any person who contravenes the provisions of subregulation (2) of this regulation shall be guilty of an offence and liable to a fine of P50 or to imprisonment for three months in default of payment.
- 11. (1) No licensee shall, without the permission of the Controller, employ as a security guard, any person who has been convicted of any offence within or outside Botswana or against whom criminal proceedings are pending within or outside Botswana.

Employment of security guards with convictions

- (2) Any licensee who wishes to employ as a security guard, any person who has been convicted of any offence within or outside Botswana, shall make application for the permission of the controller to do so in Form 5 set out in the Sechedule hereto.
- (3) Where the Controller refuses to grant his permission where application has been made by the licensee in accordance with sub regulation 2 of this regulation, he shall, in Form 5C set out in the Schedufe hereto, inform the licensee of his decision.
- 12. (1) No licensee shall display or cause to be displayed any advertisement which is indecent or in any way objectionable, or which does not relate to the services which he offers or renders.

Control of advertisements

- (2) Any person who contravenes the provisions of this regulation shall be guilty of an offence and shall be liable to a fine of P50 or to imprisonment for three months in default of payment.
- 13. Where the Controller has decided to cancel or suspend a licence in Cancellation accordance with section 11 of the Act the licensee shall surrender such licence for endorsement or cancellation or suspension as the case may be

and surrender of licences to the Controller, within the period specified by the Controller.

(2) The Controller shall give his decision to cancel or suspend a licence in Form 5B of the Schedule hereto.

Appeals

Fees

14. Any person aggrieved by the decesion of the Controller not to issue him with a licence or renew his licence may appeal to the Minister.

- 15. The following fees shall be payable to the Controller (a) P300 in respect of an application for the issue of a licence;
- (b) P200 in respect of an application for renewal of a licence;
- (c) P100 in respect of an appeal to the Minister against the decision of the Controller.

Offences and **Penalties**

16. Any person who contravenes any provision of these Regulations, for which no other penalty is prescribed, shall be guilty of an offence and liable on conviction to a fine of P1000 or to imprisonment for six months in default of payment.
