## ARRANGEMENT OF REGULATIONS

## REGULATION

IN EXERCISE of the powers conferred on the Minister of Trade and Industry by section 27 as read with section 31 (2) (b) of the Trade Act, the following Regulations are hereby made —

- 1. These Regulations may be cited as the Trade (Exemption) (No. 5) Regulations, 2012.
- 2. The following companies are exempt from the provisions of regulation 30 of the Regulations, which reserves licenses for citizens of Botswana or for companies wholly owned by citizens of Botswana

  - (f) Ackerman's Botswana (Pty) Ltd t/a Ackerman's;
  - (g) Creative Sparks (Pty) Ltd t/a Allegra;
  - (h) Stuttafords International Fashion Company (Ptv) Ltd t/a Stuttafords;
  - (i) Per Lui (Pty) Ltd t/a 7CAMICIE;
  - (j) The Branded Clothing (Pty) Ltd t/a Side Step;
  - (k) Ovais Investment (Pty) Ltd t/a JB Sports:
  - (1) Cape Union Mart Botswana (Pty) Ltd t/a Old Khakhi;
  - (m) Foschini Botswana (Pty) Ltd t/a Markhams;
  - (n) Foschini Botswana (Pty) Ltd t/a Totalsports;
  - (o) Pep Botswana Holdings (Pty) Ltd t/a Pep;
  - (p) Speciality Stores Botswana (Pty) Ltd t/a Miladys;
  - (q) The Bata Shoe Company (Pty) Ltd t/a Bata Shoes:
  - (r) The Branded Clothing (Pty) Ltd t/a Studio 88;
  - (s) Sportlandia (Pty) Ltd t/a Nike Shop; and
  - (t) Ackermans Botswana (Pty) Ltd t/a Shoe Town.
